## <u>Covid Outbreak Contingency Plan – Sept. 2021</u>

## When should my child self-isolate or miss school?



- All children MUST attend school unless they are ill or have tested positive for Covid.
- From 16th August 2021, children under 18 (or double-vaccinated adults) do not need to self-isolate or miss school if a member of their household or a contact, has Covid.
- Instead, they will need to book a PCR test but can continue coming to school so long as they have no symptoms whilst they await the result of the test.
- If your child develops Covid symptoms at home, they should stay at home and should book a PCR test, NOT a Lateral Flow test.



- If your child develops Covid symptoms at school, they will be sent home and you should book them a PCR test.
- If your child tests positive for Covid, they will need to self-isolate. The
  rest of the household does not need to self-isolate if they are under
  18 or fully vaccinated but instead should book a PCR test.

A single child tests positive	<ul> <li>A single child tests positive for Covid in a class.</li> <li>There are fewer than 5 cases in a class.</li> </ul>	<ul> <li>The child self-isolates for 10 days. Remote learning will be provided if they are well enough to complete it as outlined on the school website.</li> <li>The parents of the child are contacted directly by NHS Track and Trace to establish likely contacts.</li> <li>Likely contacts will be contacted by NHS Track &amp; Trace and advised to book at PCR Test.</li> <li>Children do not need to miss school or self-isolate whilst they wait for the result of the PCR test unless they have Covid Symptoms.</li> </ul>

OR  10% of children or staff in a class test positive within 10 days of each other.	• There have been 5 cases of Covid across a year group within 10 days which could mean that Covid is spreading within that group of children.	<ul> <li>The school will discuss the outbreak with Cornwall Public Health and agree strengthening protective measures for 10 school days, including:</li> <li>Re-introducing staff face masks for corridors &amp; communal areas.</li> <li>One-off enhanced cleaning focussing on touch points and any shared equipment.</li> <li>Adapting, limiting, or postponing indoor sporting events, trips, open days and performances.</li> <li>Reverting to video-link assemblies in classrooms.</li> <li>Reducing the number of classes staff work across.</li> <li>Resuming twice-weekly Staff Lateral flow testing if these have stopped.</li> </ul>
Covid cases continue to increase rapidly within a 10-day period.	Despite the measures indicated above, Covid cases within the school continue to rise within a 10-day period with multiple classes and staff affected, suggesting that Covid is spreading widely throughout the school.	<ul> <li>Incident Management Team meeting held between the school and Cornwall Public Health to agree further measures, for a further 10 school days, including possibly:         <ul> <li>Re-introducing class bubbles.</li> <li>Reverting to class-based school lunches.</li> <li>Limiting all non-essential visitors to school.</li> <li>Postponing all non-essential events.</li> </ul> </li> <li>Re-introducing remote learning for individual classes for 10 school days considered, as outlined on the school website.</li> </ul>

The school will inform parents of any changes to Covid measures should these be needed.
